Postdoctoral position in the field of cancer research

The Medical University of Warsaw, Department of Biochemistry, is seeking a motivated postdoctoral fellow to further develop a research project, funded by the National Science Centre (NCN, Poland), related to the modulation of anti-tumor immune response by cancer cell metabolites and validation of new targets for cancer therapy.

Qualifications

- Ph.D. degree, preferably in cancer biology and immunology, obtained within the last 7 years before the hiring date. As this position is funded by NCN, this condition should be met by the candidate (see the rule (1) at the end of the document).
- Must have a good understanding of basic scientific principles and research practices.
- Experience in the following, preferably demonstrated by track record of publications:
- Cell culture, in-vitro molecular biology techniques, hands-on experience in running multi-color flow cytometry for cell characterization and in vitro cell-based assays, and carrying out animal studies.
- Ability to pay strong attention to details and to work independently.
- Ability to analyze and interpret work published in the field, and use it to place the lab-work in context.
- Proficient in English language.

RESPONSIBILITIES

- Plan and execute experiments and procedures
- Organized and diligent in data collection and maintaining the lab notebook.
- Help with lab-duties and the supervision of lab members.
- keeping up to date with the latest trends in immuno-oncology and next-generation drugs.

Conditions of employment

The position remains open until filled, the selection will start from February 1st. Ideal starting date: March 1st, 2023 or earlier.

Qualified candidates will be invited for an interview on-site or via zoom.

Salary is based on OPUS20-NCN guidelines.

The position is offered for a maximum period of 24 months with an initial probation period of 6 months.
